UNOFFICIAL MINUTES

BOARD MEMBERS PRESENT: Russ Parmele, Cliff Gray, Lindsay Pratt, Lynne Allen, Stan Johnson, Matthew Dolge, Richard Tsang; Executive Staff: Rebel Good, Lisa Watkins.

The meeting was called to order by President Russ Parmele.

Minutes of the last membership meeting held Dec. 30, 2017 were approved.

FINANCIAL REPORT:

The financial report covering January 1, 2018 - December 31, 2018 was presented by Lisa Watkins, Financial Direct. Total revenue for the year was \$229,471.51 and total expenses were \$234,692.52 leaving a net loss of \$5,221.01. At year end, we have \$25,288.21 in the bank account and \$23,115.57 in the Arbiter account and \$13,689.76 in Accounts Receivables.

The loss (per Rebel) was due to raising the match pay to Officials without raising the payment amounts to the Schools. Also, there was additional costs due to rescheduling matches (which required increased travel fees for reassigned Officials), travel costs for assignments in WNC, and a policy decision to split up many dual matches to provide more opportunities for Officials.

FLOYD WILLIS AWARD:

Russ Parmele presented the Floyd Willis Award to Matthew Dolge for outstanding service to NCPTUA.

SPECIAL RECOGNITION:

Russ Parmele also presented Harold Chapman with a \$500 award for 40 years of service.

2018 REVIEW:

Executive Director, Rebel Good, provided the following details regarding added or increased work opportunities for NCPTUA officials, with much positive feedback in each instance:

- 1) ITF tourney in Charlotte
- 2) Additional Fall tournaments
- 3) CAA tournament
- 4) Tarheel Qualifier

Six new Officials were added in 2018 and introduced at meeting.

2019 PREVIEW:

Executive Director, Rebel Good, reported the IRS mileage rate with increase to \$.58 starting 1/1/19.

Guilford College has been added to the list of schools assigned by NCPTUA.

Rebel encouraged all interested in working with the ACC or Big 10 to contact Brad Taylor and to also increase the mileage travel restrictions within your profile.

Rebel mentioned that all ACC and Big 10 opportunities are for Chairs and anyone needing Chair experience should reach out to Lindsay Pratt for Chair experience opportunities.

Rebel stated that all Officials should ensure their blocks are up to date. Rebel reiterated that current NCPTUA policy will allow an Official assigned an ACC or Big 10 match to be released from a NCPTUA assignment, but the request must come from Brad to Rebel or Lisa, not from the Official, and a replacement must be available.

2019 ITA RULES/NCPTUA PROCEDURES REVIEW:

Rebel Good covered the significant changes to the ITA Rules for 2019. These included time between points, line-up changes, coach's code of conduct penalties, permissible coaching locations, coaching interference, and bathroom break changes. He encouraged all to read the new manual again before matches.

He explained the procedure following the ejection of a player, noting that explicit details should be included in the documentation. He encouraged all to watch for post-match violations.

Lisa Watkins has collected all ITA numbers for Officials. These must be presented to coaches in pre-match email.

Lisa Watkins provided thoughts of roving and instructions for pre-match emails to the coaches.

She encouraged all to be attentive and respectful during all roving matches.

Matthew Dolge presented a presentation on preparation for match chairs. He encouraged each Chair to always exhibit competency by being prepared, confident, engaged, and respectful and know your rules.

Rebel Good, Executive Director, stated that during 2016 we began using QuickBooks program for our bookkeeping. Arbiter is working well. We are cooperating with other assigning entities.

2017 RULES AND PROCEDURES

Rebel reviewed the 2017 ITA rules/NCPTUA procedures. It is important to keep our blocks and contact information up to date in Arbiter. He discussed the need to recruit new members. Referees should arrive at least 45 minutes prior to the match and officials at least 30 prior. Referees are responsible for allowable area for bench players, NCPTUA uniforms will not be worn after September 1, 2017 for ITA matches. ACC matches NCPTUA assigns will pay the ACC rates for officials (\$200.00 for referees and \$150.00 for officials). NCPTUA will provide overnight housing for matches over 150 miles one way or 75 miles for two day back to back matches.

CONSTITUTION AND BYLAWS REVISION:

The revision of the constitution and bylaws was presented by Chris Pelton; MSP to accept the revision.

FUTURE OF NCPTUA:

Russ discussed the need to explore the opportunity to staff events outside NC and possibly accept members outside NC.

FINANCIAL REPORT:

Financial report covering January 1, 2015 through December 31, 2015 was given by Treasurer Harold Chapman. Total revenue for the period was \$182,206.52 and total expenses were \$177,663.35 leaving a net income of \$4,543.17. Total assets were \$52,237.04 which included \$41,683.78 in bank account and \$8,263.82 in the Arbiter Pay account.

ITA COMMITTEE REPORT:

The ITA Committee report was given by Russ Parmele. The other members of the committee are Lindsay Pratt and Julia Allen. All ITA assignments are reviewed by the committee. For Fall tournaments the referees will be chosen by the ITA committee. This past year there were over 700 official days and 17 Fall tournaments. The new mentoring program for ITA was started this past year with Lindsay Pratt heading it up. We had 5 new officials complete the program this past Fall.

We are able to see all assignments in Arbiter. Non-ACC matches the Referee will be paid \$135.00 and the officials \$120.00.

EXECUTIVE DIRECTOR REPORT:

Executive Director's report was given by Rebel Good. We are working more matches than ever before. NCPTUA Fall tournaments are growing. Mars Hill and Wake Forest men have been added for the upcoming year. We were asked to contact either Rebel or Lisa if we have questions concerning Arbiter. Bookkeeping is going on line using Quick Books. We are planning to begin a newsletter in the next few weeks. Kathleen Thayne is taking over our Facebook page.

PRESIDENT'S REPORT:

President's report was given by President Tina Chandler. She explained the function of NCPTUA and how the board is working to insure fair pay and fair working conditions for our members. She also introduced the Board of Directors. NCPTUA will provide one new shirt (Blue) to all members. Beige shirt may still be worn as long as each official at the event wears beige.

Referees should complete the match report (score, travel and overtime units) after each match. We will now be paid through Arbiter Pay. Officials will also receive 1099's from Arbiter Pay. NCPTUA furnished officials for 16 college tournaments this past fall.

ITA COMMITTEE REPORT:

The ITA committee report was given by Tina Chandler. She discussed the milage pay for the upcoming year. We will continue our current car pool policy. The first 30 miles of travel will not be paid with 56 ½ cents paid for each additional mile. Pay will be \$115.00 for officials and \$130.00 for referees. Overtime pay will be \$15.00 per unit.

PRESIDENT'S REPORT:

President's report was given by Matthew Dolge. NCPTUA will begin presenting an Official Of The Year Award and the award will be named in honor of Floyd Willis for his many years of exemplary service to NCPTUA.

2. The ACC has made changes to centralize the assignments of officials for women's matches this year. Since the ACC is paying more than NCPTUA the policy of not working non-NCPTUA matches has been waived for ACC women's matches. It is possible that ACC men will follow next year. NCPTUA outerwear is permissible for ACC women's matches this year.

3. The board will look into contracting non-ITA tournaments such as junior tournaments in the future.

ITA Committee Report: Given by Tina Chandler

1. ITA Committee members are Tina Chandler, Alex Botoman, and Taylor Mattox.
2. ITA committee reviews the assignment of officials made by Executive Director.
3. We no longer have 3 area coordinators. We will now have one assistant to the Executive Director. Lisa Watkins will fill the new position.

Executive Director's Report: Given by Rebel Good

1. He discussed the assignment process and recognized several new officials.
2. The decision of the ACC to centralize the assignment of officials for women's matches was discussed. Rebel has supplied Brad Taylor (the ACC assigner) with names of qualified officials.
3. NCPTUA will continue to train officials through mentoring and shadowing.
4. The policy of not dropping an NCPTUA match for another assignment is still in effect.

NCPTUA MEMBERS PRESENT: Approximately 75 officials who attended the January 2013 ITA school.

The meeting was called to order by President Matthew Dolge.

Minutes of the last membership meeting held January 8, 2012 were approved.

Treasurer's report covering January 1, 2012 through December 31, 2012 was given by Harold Chapman, Treasurer. He reported total revenue for the period was \$211,803.67 and total expenses totaled \$210,109.62 which resulted in a net income of \$1,694.05. Total assets were \$33,101.55 which included \$30,457.37 in cash.

President Matthew Dolge discussed the following:

1. We now have two positions both filled by Rebel Good with duties as follows:
 - A. Operations Director: Communications with membership; rules updates & interpretation; contract negotiations; counseling and discipline; availability; and other administration as negotiated.
 - B. Chief Coordinator: Receive schedules from coaches; request availability ; initial assignments; post acceptance adjustments; payroll compilation; consultation with Area Coordinator's on changes, reschedules, new openings and any other issues; public relations with coaches.
2. The new NCPTUA ITA manual has been sent to all officials via email.
3. Conflict of interest policy has taken effect and will be reevaluated each year. He also discussed the appeals process.
4. Work outside of NCPTUA. Guidelines were discussed with emphases on the following; working instate D-1 matches not contracted through NCPTUA will have an impact on future assignments. If working D-2 or D-3 or NAIA matches not contracted through NCPTUA there should be an attempt to meet NCPTUA standards as far as pay and officials.

5. The need for substantial retained earnings was explained as having the ability to pay officials prior to receiving compensation from the tournaments.
6. NCPTUA uniforms should not be worn at non-NCPTUA events without prior approval.

Vice President Tina Chandler discussed the following concerning the ITA Committee:

1. All recommendations made by the committee must be approved by the BOD.
2. Recommendations submitted to the Board and approved this years included:
 - a. \$50.00 bonus to all ITA officials.
 - b. Raise of \$5.00 per match for ITA officials.
 - c. 30 cents per mile travel up to 250 miles.
 - d. Reduce Area Coordinator's from 5 to 3.

Total assets were \$34,379.98 which included \$33,144.75 in cash.

Vice-President Tina Chandler reported for the ITA committee the following changes which were approved by the Board of Directors.

1. Mileage will be paid .30 per mile up to a maximum of 220 miles.
2. Number of Area Coordinators was cut from 7 to 5.
3. Area Coordinators will be paid \$10.00 per match in their area.
4. Chief Coordinator will be paid \$10.00 per match.

President Dolge discussed the following:

1. The policy used by the Chief Coordinator in assigning matches was approved Board of Directors.
2. The Board will revisit the policy of working outside the bounds of NCPTUA as it applies to assigned matches.
3. He thanked Diane Spangler and Sol Flynt for their work with the mentoring program.
4. NCPTUA compensation is competitive with that paid in other states.
5. If anyone is approached by a coach to officiate a tournament he asked that it be coordinated through NCPTUA to insure proper payment and working conditions.

President Dolge discussed and reviewed the following 2010 activities:

- 1: Matthew Dolge accepted the presidency in August 2010 from Scott Dillon.
- 2: He discussed the importance of the mentoring program and the need to increase participation in said program.
- 3: New policy: Any person receiving compensation from or who is a student at a school will not be assigned to officiate at said school.
- 4: We are trying to move officials to more and different locations.
- 5: It is unethical to accept NCPTUA assignments and later drop these for other assignments.
- 6: Persons coordinating for schools not under NCPTUA contract will get limited assignments.
- 7: NCPTUA will use North Carolina officials when possible.

Harold Chapman discussed the need to keep a sizeable amount (\$25,000-\$30,000) in reserve in order to pay officials in a timely manner.

Motion was made and seconded to reduce the annual dues for 2011 only from \$20.00 to \$10.00. Motion passed.
